Job title: Policy Manager Reports to: Director

Purpose of the job: To lead Mental Health Europe's advocacy work, particularly in the field of mental health and the human rights of persons with psychosocial

disabilities/mental ill-health

Responsibilities include mainly:

- Leading MHE's work on the implementation of the UN Convention on the Rights of Persons with Disabilities in respect of persons with psychosocial disabilities;
- 2. Leading MHE's work on mainstreaming mental health in EU policy;
- 3. Alerting Mental Health Europe as well as the membership about threats and opportunities at the EU level of relevance for mental health and/or psychosocial disability;
- 4. Providing political intelligence, strategic support and expertise in the field of mental health and fundamental rights;
- 5. Leading the development of policy campaigning and advocacy strategies, to prepare advocacy materials, position papers, briefings, and user-friendly communication material;
- 6. Supporting the organisation of MHE events and capacity-building seminars in relation to Human Rights and EU policies of relevance for mental health and/or psychosocial disability;
- 7. Co-ordinating and support the work of the MHE Human Rights Committee and the "Beyond the Biomedical Paradigm" task force and to foster close links and co-operation with MHE's members;
- 8. Support MHE's Project Coordinator in the implementation on the "Shedding Light" project on transparency;
- 9. Liaising with relevant institutions and human rights bodies;

- 10. Representing MHE at meetings and events across Europe
- 11. MHE being a small office, other tasks may be assigned from time-to-time.

Requirements for the position

Essential:

- Good knowledge of the mental health field or proven interest or experience in the sector;
- Excellent knowledge of the EU institutions, relevant EU and International policy in the human rights and mental health field, along with experience of policy advocacy work;
- Understanding of and commitment to the psychosocial model of mental health and social/human rights model of disability;
- Fluency in English native level (written, spoken);
- Excellent communication skills and ability to communicate clearly and concisely to a variety of audiences;
- Ability to work autonomously, to plan, prioritise and to take initiative;
- Ability to meet deadlines;
- Excellent interpersonal skills and ability to work in a small, busy, international team;
- Experience from working within the NGO field at the EU or international level;
- Experience of working in a membership organisation;
- Willingness to travel;
- Computer literacy.

Desirable:

- Good knowledge of other European languages (preferably French or German)
